Part 4 – Police Information Check Section Personnel Only – Self-Declaration *This declaration is to be completed by the applicant in the presence of police agency personnel only* Self-declaration of a Criminal Record is a process whereby the applicant declares their adult criminal record convictions to the Police Service in accordance with CPIC policy requirements and federal laws. Self-Declaration should NOT include: Conviction for which a pardon / record suspension has been received Youth Convictions (Youth Criminal Justice Act) Absolute / Conditional Discharges Offences where there were no convictions Provincial / Municipal Offences Charges dealt with outside of Canada Any charges for which you received a stay of proceedings In order to release criminal convictions identified through a name based query, the Edmonton Police Service must be satisfied that the applicant's declared criminal record information is a match to their registered criminal record held at the RCMP National Repository of Criminal Records. If the Edmonton Police Service is not satisfied that the applicant's declared criminal record information is a match to their registered criminal record held at the RCMP National Repository of Criminal Records they may require the applicant to submit fingerprints to the RCMP National Repository of Criminal Records.
